JESPA IN THE NEWS Jeffco Schools pivot – expand Grab and Go food program

Community group thinks it's a good first step but wonders if it's enough during pandemic



Under pressure from JESPA, and partner organization Coloradans for the Common Good, Jeffco Public Schools rescinded their call for food service worker furloughs, instead expanding the USDA free meal program and putting food service and transportation workers back to work. JESPA members, church leaders, and local nonprofit leaders came together to push the district to do what's right for students by expanding grab-and-go sites, extending hours, and delivering food directly to the community on buses. All together, students now have 50 ways to get food, a vast improvement over the original plan of only 15 sites. We couldn't be more proud of our workforce, advocating for students in this difficult time, building relationships across the community with churches and foodbanks, and protecting JESPA workers' jobs!

A MESSAGE FROM THE PRESIDENT

When I was working as a library paraprofessional at Kendrick Lakes Elementary School (2006-2011), I had no idea about everything involved in public education. Before becoming active in union work in 2014, I never understood the challenges facing public education or the extent to which it is in danger. Indeed, I have never met anyone who said they don't care about students, but frequently our actions don't align with our values. JESPA is on the forefront of helping members/ESP understand how to better align our values with our actions. You have more power than you know!



So here we stand at the beginning of another calendar year with a worldwide pandemic raging on, students still not back to school like they should be (10 months later), students of color and/or those living in poverty being most at risk, staff/teachers/school-based administrators being asked to put their lives on the line everyday for the sake of a "normally" functioning society, AND a critical school board majority (3 of 5 seats up this year) election in November. Some days it all feels like too much!

I want to continue to fight for competitive wages and job security because anything less is disrespectful to workers and families because one full-time job should be enough.

New Federal Bill Promotes Public Schools as Community Hubs

Integrated academic, health, nutrition, and economic services will transform outcomes for all students.



A new bill in Congress recognizes the foundational role our public schools play in the lives of our communities and would broaden their services to help students and their communities thrive.

U.S. Senators Sherrod Brown (D-OH), Kirsten Gillibrand (D-NY), and Chris Van Hollen (D-MD) introduced <u>The Full-Service Community School Expansion Act of</u> <u>2020</u>. The bill will help schools and districts serve students, families, and communities by providing resources for public schools to be community hubs and provide integrated student supports, expanded and enriched learning opportunities, collaborative leadership, and family and community engagement – including medical, mental, and nutrition health services, mentoring and youth development programs, and continuing education courses.
